Description

The Legal Discovery Using Veritas Enterprise Vault 12.2 Discovery Accelerator course is designed for those who use Discovery Accelerator to search, review, and prepare archived items in support of information requests. In addition, using research folders and setting up marks and tags are discussed. Also included are analytics and client review.
